A. TUGASAN TEMPAT KERJA

1. Pilih satu tempat kerja.

3. Pilih **SATU (1)** kawasan kerja yang terdapat pekerja yang bekerja di situ dan dibekalkan dengan pengalihudaraan atau penyaman udara sepunya.
4. Lakukan tinjauan tapak di kawasan kerja tersebut.
5. Lakukan soal selidik dan temu bual pekerja di kawasan kerja tersebut.
6. Lakukan persampelan udara.
7. Lakukan penilaian sistem pengalihudaraan.
8. Sediakan laporan penilaian dan pemonitoran mengikut format laporan yang dilampirkan.

B. FORMAT LAPORAN

(i) Format Teks

1. Tugasan ini hendaklah ditaip dengan jelas menggunakan sama ada dalam Bahasa Malaysia sepenuhnya atau Bahasa Inggeris.
2. Jenis tulisan yang digunakan mestilah *Times New Roman* bersaiz 12 dengan langkau 2 baris.
3. Jidar (margin) kanan dan kiri mestilah berukuran 2.5cm, manakala jidar atas dan bawah mestilah berukuran 2.5cm dan diformatkan kepada saiz kertas A4.
4. Gunakan sebelah halaman kertas sahaja.
5. Laporan mesti mempunyai muka depan dan mesti dijilidkan (sila rujuk *Lampiran I*).
