Laksanakan pemonitoran diri menggunakan persampelan berturutan jangkamasa penuh (*full period consecutive sampling*) untuk sekurang-kurangnya dua (2) jenis bahan kimia, berbahaya kepada kesihatan dan sekurang-kurangnya dua (2) orang pekerja di tempat kerja tersebut dan bincangkan teknik pemilihan pekerja.
5. Sediakan laporan pemonitoran mengikut format laporan yang dilampirkan.

**B. FORMAT LAPORAN**

- iii. Margin kiri dan kanan mestilah berukuran 2.5 cm, manakala margin atas dan bawah mestilah berukuran 2.5 cm dan diformatkan kepada saiz kertas A4.

- v. Laporan mesti mempunyai muka depan (sila rujuk Lampiran 1) dan mesti dijilidkan.
